Credit cards for individuals other than the account owner will not be authorized for online payment.

All items must be removed from their auction location within 10 days of the auction closing date. This removal deadline is firm. All items not removed by the removal deadline will be considered abandoned, the winning bidders claim to those items will be forfeited and any payments made will NOT be refunded. Bidders requesting a pickup extension must notify us by email only at elkgrove@rliquidators.com prior to the removal deadline. Verbal and phone requests for extensions are not accepted. Failure to remove items, or abuse of the extension policy, are grounds for terminating a bidders account.
