Credit cards for individuals other than the account owner will not be authorized for online payment.

All items must be removed from their auction location within 10 days of the auction closing date. This includes weekends, closed days, and holidays. This removal deadline is firm. All items not removed by the removal deadline will be considered abandoned, the winning bidders claim to those items will be forfeited and any payments made will NOT be refunded. BidRL Elk Grove is CLOSED on Sundays and Mondays. If the 10th day (for pickup) falls on a Sunday or a Monday, you must pick up your item before then; so on the preceding Saturday by 3:00pm.
